"[Discourse analysis is a] task that consists of not – of no longer – treating discourses as groups of signs (signifying elements referring to contents or representations) but as **practices that systematically form the objects of which they speak**. 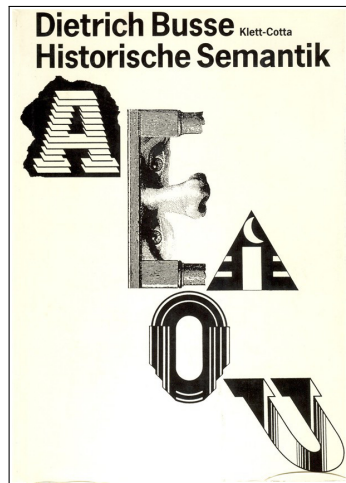

"Historical discourse semantics construes [...] the scenario of the collective knowledge of a given discourse community in a given era with regard to the thematic field or the field of meaning or the discourse formation, that has been selected as a subject of research. [...] The description of collective knowledge can only cover that section of discourse that is taken under analytic consideration. [...] Thus the scenario only describes the surrounding of a separate field, it cannot grasp the complete collective knowledge of a given era."

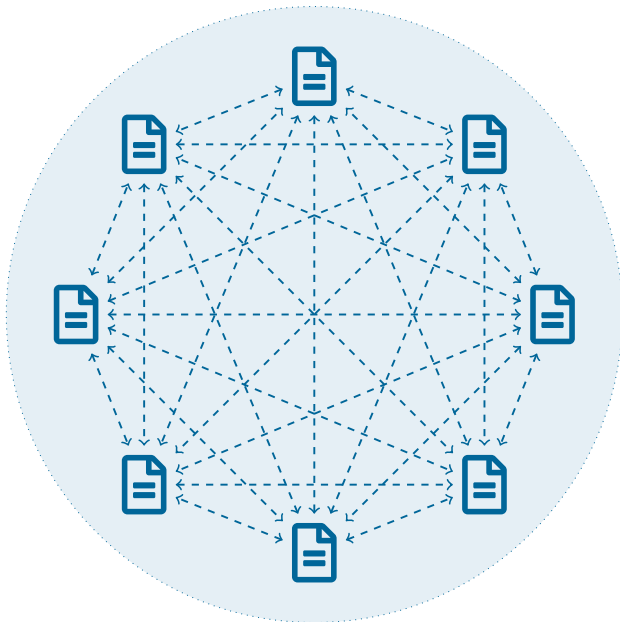

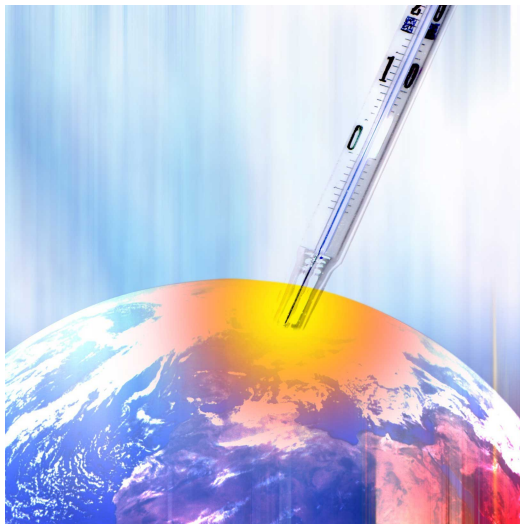

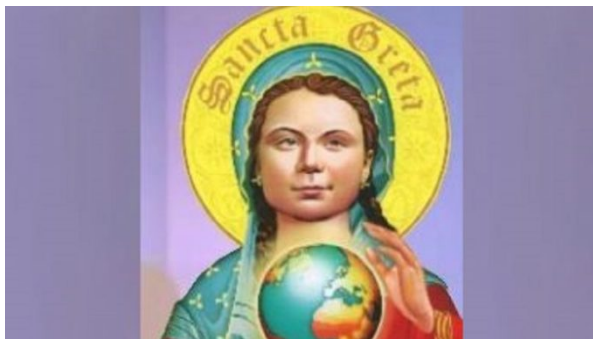
